**TRUSTEES REPORT

The Trustees present their annual report together with the financial statements and auditors' report of the charitable company for the year ended 31 August 2020. The annual report serves the purpose of a Trustees' report, a Directors' report under company law, and a report to parents.

The Trust operates an academy for pupils aged 11 to 18 in Bradford on Avon. It has a pupil capacity of 1,350 and had a roll of 1,421 in the school census on 1 October 2019.

**STRUCTURE, GOVERNANCE AND MANAGEMENT**

**Constitution**

The School is a company limited by guarantee and an exempt charity. The charitable company's Memorandum and Articles of Association are the primary governing documents of the School.

The Trustees of St Laurence School Academy Trust are also the directors of the charitable company for the purposes of company law.

Details of the Trustees who served throughout the year, except as noted, are included in the Reference and Administrative Details on pages 1 to 2.

**Members' liability**

Each member of the charitable company undertakes to contribute to the assets of the Company in the event of it being wound up while they are a member, or within one year after they cease to be a member, such amount as may be required, not exceeding £10, for the debts and liabilities contracted before they ceased to be a member.

**Trustees' Indemnities**

Trustees benefit from indemnity insurance purchased at the School's expense to cover the liability of the Trustees which by virtue of any rule of law would otherwise attach to them in respect of any negligence, default or breach of trust or breach of duty of which they may be guilty in relation to the School, provided that any such insurance shall not extend to any claim arising from any act or omission which the Trustees knew to be a breach of trust or breach of duty or which was committed by the Trustees in reckless disregard to whether it was a breach of trust or breach of duty or not and provided also that any such insurance shall not extend to the costs of any unsuccessful defence to a criminal prosecution brought against the Trustees in their capacity as Directors of the School. The limit of this indemnity is £5,000,000.

**TRUSTEES**

**Method of Recruitment and Appointment or Election of Trustees**

The School shall have the following Trustees as set out in its Articles of Association and funding agreement:

- 4 Foundation Trustees; 2 appointed by each of the 2 foundations (Salisbury Diocesan Board of Education and Lord Fitzmaurice's Educational Foundation);
- up to 6 Trustees who are appointed by the Academy Trust Board;
- no more than 4 Parent Trustees who are elected by Parents of registered pupils at the School;
- no more than 2 Staff Trustees, elected by the staff and appointed by the Governing Body;
- the Headteacher is an ex officio Trustee.

Except for the Headteacher and the incumbent of the Parish, the term of office for Trustees is four years. Subject to remaining eligible to be a particular type of Trustee, any Trustee can be reappointed and re-elected.

When appointing new Trustees, the Academy Trust Board (ATB) will give consideration to the skills and experience mix of existing Trustees in order to ensure that the Board of Trustees (also known as the Full Governing Body, FGB) has the necessary skills to contribute fully to the School's development.

**Policies and Procedures Adopted for the Induction and Training of Trustees**

The training and induction provided for new Trustees will depend upon their existing experience. As there are normally only two or three new Trustees a year, induction tends to be done informally and is tailored specifically to the individual. Advantage is taken of specific courses offered by the Local Authority and other bodies. All Trustees are provided with copies of policies, procedures, minutes, accounts, budget plans and other documents which they will need to fulfil their role.

There is a Trustees' seminar organised each year, which includes training sessions to keep the Trustees updated on relevant developments impacting on their roles and responsibilities.

**Organisational Structure**

The Board of Trustees (FGB operates in accordance with the Scheme of Delegation and is responsible for setting general policy, agreeing an annual budget, monitoring the use of budgets and other measures, approving the statutory accounts, and making the major decisions about the strategic direction taken by the School, capital expenditure and the appointment of the Headteacher and the Deputy Headteacher.

As per the Scheme of Delegation, the FGB meets seven times per year. All decisions reserved to the Trustees are taken by the board as a whole. Trustee committees meet six times per year to consider detailed matters and recommend decisions to the FGB.

During the period ended 31 August 2020 the structure of Committees was:

- Community and Ethos (CE)
- Finance, Facilities and Environment (FFE)
- Standards (ST)
- Strategy (SY) (Chairs of all committees plus Chair and Vice Chair of Trustees and the Headteacher)

Responsibility for day to day management of the School lies with the Headteacher and Senior Leadership Team (SLT). The SLT comprises the Headteacher, 1 Deputy Headteacher, 4 Assistant Headteachers and the Director of Finance & Operations. The SLT control the School at an executive level, implementing the policies agreed by the Trustees and reporting back to them. The Headteacher is responsible for the authorisation of spending within agreed budgets and for the appointment of staff, although Trustees will appoint the Headteacher and Deputy Headteacher and will sit on the appointments panel for other SLT members, and will often be invited to sit on the appointment panels for other staff members.

The Headteacher is the Accounting Officer.

**Arrangements for Setting Pay and Remuneration of Key Management Personnel**

The SLT comprise the key management personnel of the Academy in charge of directing and controlling, running and operating the Trust on a day to day basis. The Board of Trustees are also considered to be key management personnel.

All Trustees give their time freely and no Trustee received remuneration in the year for their work as a Trustee. Details of any Trustees' expenses and related party transactions are disclosed in the notes to the accounts.

The pay of the SLT is reviewed annually. National pay scale increases as agreed with unions are applied to the current pay point within range of each member of the SLT. Any changes to pay grade are only made following successful performance management review, until the upper end of their salary scale is reached. The Headteacher appraises all members of the SLT and makes recommendations to the Board of Trustees pay panel regarding scale point changes. The appraisal of the Headteacher is carried out in consultation with the School's Improvement Advisor and any change to pay grade is assessed and approved by the Board of Trustees pay panel.

**Connected Organisations, including Related Party Relationships**

St Laurence School is a member of Learning Futures Limited which is a collaborative organisation made up of secondary schools and Wiltshire College, largely located in the western part of Wiltshire. This alliance exists to facilitate collaboration between the schools but does not operate at governance level and there is no impact on operating policies.

St Laurence School also has links with other local networks and organisations:

- Five feeder primary schools forming the Bradford on Avon Cluster for the provision of cluster services;
- Lord Fitzmaurice's Educational Foundation (a Foundation Member of the Academy Trust Board), to which the school applies for donations to support the object of the Trust; and
- The Colonel William Llewellyn Palmer Educational Charity to which the School applies for grant aid to assist pupils from low income backgrounds in the purchase of uniforms and payment of school trips.

**OBJECTIVES AND ACTIVITIES**

**Objects and Aims**

As per the Memorandum and Articles of Association, the School's Objects are restricted to the following:

"To advance for the public benefit education in Bradford on Avon and the surrounding area, in particular but without prejudice to the generality of the foregoing by:

- Establishing, maintaining, carrying on, managing and developing a school with a designated Church of England religious character offering a broad and balanced curriculum ("the Academy") conducted in accordance with the principles, practices and tenets of the Church of England both generally and in particular in relation to arranging for religious education and daily acts of worship (as required by the Funding Agreement) and in having regard to the advice of the Diocesan Board of Education; and
- maintaining, carrying on, managing and developing the long standing heritage of the local community's engagement with education in Bradford on Avon and surrounding parishes of Winsley, South Wraxall, Atworth, Monkton Farleigh and Limpley Stoke and promoting education in subjects that address the needs of industry, commerce and technology particularly in relation to the Foundation's Charity Commission Scheme dated 31 October 1986."

**Mission and Values**

Our mission is to develop young people with active and creative minds. Within the context of our Christian and civic foundations we aim to foster a sense of understanding and compassion for others, and the courage to act on our beliefs.

**Objectives, Strategies and Activities**

The key priorities for the academic year ended 31 August 2020 are included in the School Development Plan 2019-2020:

**Objectives**

1. Develop our collective ethos and vision
2. Develop a curriculum that meets the needs of all students
3. Develop well-being across the school (students and staff)

**Public Benefit**

The Trustees confirm that they have complied with the duty in Section 17(5) of the Charities Act 2011 to have due regard to the Charity Commission's general guidance on public benefit in exercising their powers or duties. They have referred to this guidance when reviewing the School's aims and objectives and in planning its future activities.

**STRATEGIC REPORT**

**Achievements and Performance**

At the start of the academic year 2019-20 the Number on Roll was 1,421 which included 287 students in the sixth form, placing us in the highest quintile nationally for secondary school size.

Due to COVID-19, no external examinations were sat in 2020. St Laurence School students achieved grades based on the Centre Assessed Grades (CAG) process, as defined by Ofqual. This process was carried out with the utmost thoroughness and integrity, as confirmed by our external School Improvement Adviser. As a result of this process, our students celebrated another very good set of GCSE outcomes in 2020. We are proud that 10% of the year group achieved 8 or more grades of 7+ (A or A\* or equivalent) across their subjects. There will be no published Progress 8 score for 2020, but we are confident that these results maintain our high ranking amongst Wiltshire schools. 82% of students achieved at least a grade 4 (standard pass) in both English and Maths. In this difficult year, when disadvantaged students were disproportionately affected by school closure, 49% of our Pupil Premium students achieved grade 4+ in English and Maths; while this is a fair achievement, it highlights the need for continued intensive work with this group, for which the attainment levels had been higher in the last few years.

Our A level students have, despite the COVID-19 disruptions, continued to achieve extremely well, with an average grade of B and 39% of all the grades at A\* A, 88% at grade C or above and 100% pass grades. There is unlikely to be any national data against which to compare these but our ALPS progress score has risen to a teaching and learning score of 2 – “outstanding” – which places St Laurence sixth form between the 90th and 99th percentile nationally. This is an even greater cause for celebration given that this was our largest ever examination cohort at 136 students.

Since March 2020, our teaching and associate staff have had to adapt rapidly to the completely new demands of school closure and partial re-opening in June. Throughout the entire closure period, in-school provision was made for vulnerable students and the children of key workers. In addition, excellent pastoral care was provided for students, in addition to remote learning.

Since our “Good” Ofsted rating in June 2017 we have continued to focus on our two key achievement priorities:

- continue to raise the quality of teaching so that lower prior attaining pupils can maximise their potential: most of this small group of students follow a bespoke curriculum which does not include the full programme of GCSE subjects; however the development of, and investment in, this programme is a key part of our strategy to address this priority. Internal data shows that, in the 2020 GCSE outcomes, the progress of this group improved from 2019.
- continue to address variations in outcomes and quality of teaching between subjects so that pupils achieve as well in all subjects as they do in the best: in the 2020 GCSEs, internal data shows that the progress made in our hitherto weaker, “open bucket” subjects has risen significantly. This shows continuing impact of our work to improve the rigour of teaching and assessment in these areas of the curriculum. The work of our new Heads of Department team has been a key factor in this improvement work, following the re-structure carried out in 2019.

Unfortunately, as a result of COVID-19, much of our co-curricular programme had to be set aside. However, students continued to participate in the Duke of Edinburgh programme and a number of other school trips and expeditions took place prior to closure in March, including the senior ski trip and Geography field trips at home and in Italy. The current period of suspension of many trips has provided a window for staff training and preparation, led by the Head of Learning Outside the Classroom.

We await the resumption of national inspections, both for SIAMS (Church school distinctiveness) and OFSTED and are ready for both.

**Key Performance Indicators**

A key financial performance indicator is the level of general reserves held at the Balance Sheet date. In particular, the management of spending against General Annual Grant (GAG) requires special attention as pay and other expenditure costs are increasing more than sources of income in the current climate.

As funding is based on pupil numbers this is also a key performance indicator. Funded pupil numbers for 2019-20 were 1,411 We continue to be oversubscribed for entry into Y7, and it is anticipated this will continue.

Another key financial performance indicator is staffing costs as a percentage of GAG. For 2020 this was 90.6%, compared to 92.0% in 2019.

**Going Concern**

After making appropriate enquiries, the board of trustees has a reasonable expectation that the School has adequate resources to continue in operational existence for the foreseeable future. For this reason, it continues to adopt the going concern basis in preparing the financial statements. Further details regarding the adoption of the going concern basis can be found in the Going concern policy.

**FINANCIAL REVIEW**

**Financial Review**

Most of the School's income is obtained from the DfE via the ESFA (Education and Skills Funding Agency) in the form of recurrent grants, the use of which is restricted to particular purposes. The grants received from the DfE during the period ended 31 August 2020 and the associated expenditure are shown as Restricted Funds in the Statement of Financial Activities.

The School also receives grants for fixed assets from the DfE and these are shown in the Statement of Financial Activities as restricted income in the fixed asset fund. The restricted fixed asset fund balance will normally be reduced by annual depreciation charges over the useful life of the assets concerned as defined in the School's accounting policies.

The net movement in funds for the year is a deficit of £447,916, excluding restricted fixed asset funds, and the restricted pension reserve. However, included within this figure is Condition Improvement Fund (CIF) expenditure of £262,435 which is in relation to a specific project, and further capital spend from reserves of £332,211, which was planned. As such, the net operational result for the year is a surplus of £146,730.

At 31 August 2020 the net book value of fixed assets was £17,291,050. Movements in tangible fixed assets are shown in Note 13 to the financial statements. The assets were exclusively for providing education and the associated support services to the pupils of the School.

The School has supported its income throughout the period by raising funds e.g. through the letting of its premises outside of school hours. All income received is used to implement the strategic and operational needs of the School.

At the end of the financial period the School remains in a strong financial position with good reserves going forward, despite unavoidable changes to Teacher's and Local Government Pension contributions rates coupled with flat cash funding rates by the DfE. The Trustees and Senior Leadership Team are implementing a Medium-Term Financial Plan (MTFP) to moderate these factors.

**Reserves Policy**

The Trustees have determined there is a requirement for a revenue reserve to be created to fund future expenditure related to the School Development Plan (SDP), strategic long term aims and developments. The decision regarding the level of this reserve is delegated to the Finance, Facilities and Environment Committee (FFE). This has been agreed to be set at a minimum of 2% of income, with a preferred long-term level of 5%. Total reserves of the School amount to £16,146,125 although £15,319,841 of this is invested in fixed assets or represents non-GAG restricted funds. The remaining £826,284 (representing £826,284 unrestricted funds and £Nil unspent GAG) is the balance that the Trustees monitor in accordance with the Board's Reserves Policy, and excess reserves are held to cover the risks in the paragraphs below.

The defined benefit pension scheme reserve has a negative balance. The effect of the deficit position of the pension scheme is that the Academy Trust is paying higher employers' pension contributions over a period of years. The higher employers' pension contributions will be met from the Academy Trust's budgeted annual income. Whilst the deficit will not be immediately eliminated, there should be no actual cash flow deficit on the fund, nor any direct impact on the free reserves of the Academy Trust.

**Investment Policy**

The Trustees' Finance, Facilities and Environment Committee (FFE) aims to manage the cash balances of St Laurence School to provide for the day to day working capital requirements of its operations, whilst protecting the real long term value of any surplus cash balances against inflation. In addition, FFE aims to invest surplus cash funds to optimise returns but ensuring the investment instruments are such that there is an absolute minimum risk to the loss of these cash funds. Due to the nature and timing of the receipt of funding, the Academy may at times hold cash balances surplus to its short-term requirements. The Trustees have authorised the opening of additional short-term bank investment accounts to take advantage of higher interest rates. No other form of investment is authorised.

**Principal Risks and Uncertainties**

The Trustees have reviewed the major risks to which the Academy Trust is exposed together with the operating, financial and compliance controls that have been implemented to mitigate those risks.

The principal risks and uncertainties facing the School are as follows:

**Staffing** – the risk of the loss of a key member of staff and/or the inability to recruit teaching staff in key curriculum areas. To mitigate, Trustees work closely with senior staff to ensure the School has a broad level of expertise across the curriculum and appoint staff accordingly. The School maintains effective cover arrangements for planned and ad hoc leave. The Headteacher has developed succession plans for changes in the SLT.

**Financial** – the School has considerable reliance on continued Government funding through the ESFA. There is a risk that the budget could fall into deficit due to the Government's changes to pensions and the Government policy of underfunded pay rises. The uncertainty over budgets continues but the SLT and FGB have rigorous monitoring arrangements and a Medium Term Financial Plan (MTFP) is in place.

**Reputational** – this risk arises from the possibility in a declining external assessment, deficiencies in leadership and/or pupil progress which adversely affects recruitment of students to the School and therefore funding levels. The June 2017 OFSTED report and 2018/19 exam successes enhanced the reputation of the School, thereby negating much of this risk.

**Budget** – the risk is that the School delivers a deficit budget and erodes the risk assessed minimum reserves across the MTFP. To mitigate the risk, the SLT and Trustees continue to develop savings plans in order to balance the MTFP. The School holds a good level of reserves to help the School implement transitional arrangements, including financial support for restructuring if necessary.

The Trustees and FGB have assessed the major risks to which the School is exposed, in particular those relating to its finances, teaching, facilities and other operational areas. The Trustees have implemented a number of systems to assess and minimise those risks, including internal controls described elsewhere. Where significant financial risk still remains, they have ensured they have adequate insurance cover.

The School has agreed a Risk Management Strategy and maintains a Risk Register which is reviewed and updated on at least an annual basis. An overview of risk management has been presented to the FFE committee by the Headteacher and the Director of Finance and Operations. After careful consideration of the Risk Register by SLT the top risks identified, including financial risks, have been discussed by FFE and these were also published to staff. The Risk Register is available to staff and is updated as and when new risks are identified.

The COVID-19 global pandemic had an impact on all the above areas. A pandemic had not been identified on the risk register. However, the school continued to manage its staffing, budget, and reputational risks within an ever changing COVID-19 framework. With the first closure announced in March the school remained open to vulnerable and key worker students throughout the closure period. Teaching resources continued to be provided on-line for students with a limited face to face programme of teaching for Year 10 and 12 in June. Providing provision for the 'on-site' students incurred additional unexpected costs such as providing catering provision for staff on duty in school. The full programme of Trustees meetings continued as planned with virtual meetings. All reasonable and practical measures were taken to ensure the Government guidance was adhered to and the Trust could continue to fulfil the educational and pastoral needs of all our students.

The Governments Procurement Policy Note (PPN) PPN02/20 and PPN04/20 for public bodies to continue to ensure continuity of service to suppliers meant the school was unable to make savings on staff such as invigilators. Staff like this who were not able to carry out their usual service for exams still received a payment. Due to the closure, the school also lost a significant portion of lettings income. The increased costs for handwashing facilities, increased school hygiene equipment and increased cleaning routines also increased the operating costs of the school. With July Government guidance on the September opening

requirements the school used a portion of reserves to buy and hire additional toilet and classroom facilities to deliver a bubble system. The school submitted a claim to the DFE for the additional costs of some £67,000. However, this is not all the costs that the school has incurred due to COVID-19. Significant time and resources such as increased supply costs have impacted on the school finances and impacted on the reserves available for future projects for the school.

The COVID-19 lockdown also delayed the completion of the ongoing CIF and Science projects. These were for due for completion in March and were delayed until September 2020. This has meant the CIF final funding amounts weren't issued to the school until November 2020.

While the School is oversubscribed, risks to revenue funding from a falling roll are small. However, the real terms reduction in post 16 funding levels, the freeze on the Government's overall education budget, changes in funding arrangements for High Needs students, and increasing employment and premises costs mean that budgets will be increasingly tight in coming years.

The Trustees examine the financial health of the School formally, at least 6 times per year. They review performance against budgets and overall expenditure by means of regular update reports at FFE meetings. The chair of FFE makes regular reports to FGB on the financial status of the School. The FGB ensure there are sufficient funds held to cover all known and anticipated commitments.

At the year end, the School had no significant liabilities arising from trade creditors or debtors that would have a significant effect on liquidity.

The Board of Trustees recognises that the defined benefit pension scheme deficit (Local Government Pension Scheme), which is set out in Note 23 to the financial statements, represents a significant potential liability. However, as the Trustees consider that the School is able to meet its known annual contribution commitments for the foreseeable future, this risk from this liability is minimised.

**FUNDRAISING**

Traditionally, funds have been raised for the School by the St Laurence School Association (SLSA), the School's PTA with whom the school works closely. Given the difficult financial environment, the School is looking at additional means of raising income, including donations from parents, increased lettings, or Bids and Grants. Fundraising activities are either run or closely monitored by the School.

**PLANS FOR FUTURE PERIODS**

The School is continuing to improve the education facilities and will be applying for two CIF bids this year. The School will be focusing on a new Additional Education Needs build to replace thirty-year-old temporary classrooms which have reached their end of life. The school will be using a portion of reserves to support the CIF bid application.

The School will continue to strive to provide outstanding education and to improve the levels of performance of its students at all levels. The School will continue to aim to attract and retain high quality teachers and associate staff in order to deliver its objectives. We have identified the progress of all students in each key stage as a key priority, as well as a continuing focus on further raising the achievement of vulnerable groups of students, building on the impact we can already demonstrate.

**FUNDS HELD AS CUSTODIAN TRUSTEE ON BEHALF OF OTHERS**

The School and its Trustees as a body do not act as the Custodian Trustees of any other Charity.

During the year, no cost was incurred by the School in relation to employees acting as a relevant union official, and no time was spent on facility time.

**REVIEW OF VALUE FOR MONEY**

As Accounting Officer, the Headteacher has responsibility for ensuring that the School delivers good value in the use of public resources. The Accounting Officer understands that value for money refers to the educational and wider societal outcomes achieved in return for the taxpayer resources received.

The Accounting Officer considers how the School's use of its resources has provided good value for money during each academic year, and reports to the Board of Trustees where value for money can be improved, including the use of benchmarking data where appropriate. The Accounting Officer for the School has delivered improved value for money during the year by:

1. Ensuring extremely efficient deployment of teaching staff;
2. Re-distributing funding to protect front line services;
3. Ensuring all senior leaders understand and own strategies for reducing costs and optimising efficiency;
4. Drawing up a Medium Term Financial Plan (MTFP); and
5. Scrutiny of all major investment proposals for value for money.

**THE PURPOSE OF THE SYSTEM OF INTERNAL CONTROL**

The Board of Trustees is of the view that there is a formal ongoing process for identifying, evaluating and managing the School's significant risks that has been in place for the year 1 September 2019 to 31 August 2020 and up to the date of approval of the annual report and financial statements. This process is regularly reviewed by the Board of Trustees.

**THE RISK AND CONTROL FRAMEWORK**

The School's system of internal financial control is based on a framework of regular management information and administrative procedures including the segregation of duties and a system of delegation and accountability. In particular, it includes:

- comprehensive budgeting and monitoring systems with an annual budget and periodic financial reports which are reviewed and agreed by the Board of Trustees
- regular reviews by the Finance, Facilities and Environment Committee of reports which indicate financial performance against the forecasts and of major purchase plans, capital works and expenditure programmes
- setting targets to measure financial and other performance
- clearly defined purchasing (including asset purchase or capital investment) guidelines
- identification and management of risks

The Board of Trustees has considered the need for a specific internal audit function and has decided not to appoint an internal auditor. However, the Trustees have appointed Dr I Blagbrough, an unpaid Trustee, to provide reports on the internal controls in place to the FFE committee. The work has been carried out by the Local Authority Finance and Budget Team, delivering a Financial Controls and Assurance Report (FCAR)

This work includes giving advice on financial matters and performing a range of checks on the School's financial systems. Four times a year, the appointed trustee reports to the Board of Trustees via the FFE Committee on the operation of the systems of control and on the discharge of the Board of Trustees financial responsibilities.

In the period ending 31 August 2020, 4 FCAR reports have been delivered. No high risk control issues have arisen out of the work undertaken on behalf of the Board of Trustees.

Any medium and low risk issues which have been identified are considered by the Director of Finance & Operations and the Finance Department. Control measures have been put in place to alleviate these where appropriate. Medium level risks are manageable risks which exist on the margins of the school's risk appetite. Low level risks are insignificant risks which exist within the school's risk appetite.

**1. ACCOUNTING POLICIES**

A summary of the principal accounting policies adopted (which have been applied consistently, except where noted), judgments and key sources of estimation uncertainty, is set out below.

**1.1 BASIS OF PREPARATION OF FINANCIAL STATEMENTS**

The financial statements of the School, which is a public benefit entity under FRS 102, have been prepared under the historic cost convention in accordance with the Financial Reporting Standard Applicable in the UK and Republic of Ireland (FRS 102), the Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (Charities SORP (FRS 102)), the Academies Accounts Direction 2019 to 2020 issued by ESFA, the Charities Act 2011 and the Companies Act 2006.

St Laurence School Academy Trust meets the definition of a public benefit entity under FRS 102.

The Consolidated Statement of Financial Activities (SOFA) and Consolidated Balance Sheet consolidate the financial statements of the School and its subsidiary undertaking. The results of the subsidiary are consolidated on a line by line basis.

The School has taken advantage of the exemption allowed under section 408 of the Companies Act 2006 and has not presented its own Statement of Financial Activities in these financial statements.

**1.2 GOING CONCERN**

The Trustees assess whether the use of going concern is appropriate i.e. whether there are any material uncertainties related to events or conditions that may cast significant doubt on the ability of the School to continue as a going concern. The Trustees make this assessment in respect of a period of at least one year from the date of authorisation for issue of the financial statements and have concluded that the School has adequate resources to continue in operational existence for the foreseeable future and there are no material uncertainties about the School's ability to continue as a going concern, thus they continue to adopt the going concern basis of accounting in preparing the financial statements.

**1. ACCOUNTING POLICIES (continued)**

**1.3 INCOME**

All incoming resources are recognised when the Group has entitlement to the funds, the receipt is probable and the amount can be measured reliably.

• **Grants**

Grants are included in the Consolidated Statement of Financial Activities on a receivable basis. The balance of income received for specific purposes but not expended during the period is shown in the relevant funds on the Balance Sheet. Where income is received in advance of meeting any performance-related conditions there is not unconditional entitlement to the income and its recognition is deferred and included in creditors as deferred income until the performance-related conditions are met. Where entitlement occurs before income is received, the income is accrued.

General Annual Grant is recognised in full in the Consolidated Statement of Financial Activities in the year for which it is receivable and any abatement in respect of the year is deducted from income and recognised as a liability.

Capital grants are recognised in full when there is an unconditional entitlement to the grant. Unspent amounts of capital grants are reflected in the Balance Sheet in the restricted fixed asset fund. Capital grants are recognised when there is entitlement and are not deferred over the life of the asset on which they are expended.

• **Donations**

Donations are recognised on a receivable basis (where there are no performance-related conditions) where the receipt is probable and the amount can be reliably measured.

**1.4 EXPENDITURE**

Expenditure is recognised once there is a legal or constructive obligation to transfer economic benefit to a third party, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is classified by activity. The costs of each activity are made up of the total of direct costs and shared costs, including support costs involved in undertaking each activity. Direct costs attributable to a single activity are allocated directly to that activity. Shared costs which contribute to more than one activity and support costs which are not attributable to a single activity are apportioned between those activities on a basis consistent with the use of resources. Central staff costs are allocated on the basis of time spent, and depreciation charges allocated on the portion of the asset's use.

• **Charitable activities**

These are costs incurred on the Group's educational operations, including support costs and costs relating to the governance of the Group apportioned to charitable activities.

All resources expended are inclusive of irrecoverable VAT.

**1.5 TAXATION**

The School is considered to pass the tests set out in Paragraph 1 Schedule 6 of the Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes.

Accordingly, the School is potentially exempt from taxation in respect of income or capital gains received within categories covered by Part 11, chapter 3 of the Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes.

**1. ACCOUNTING POLICIES (continued)**

**1.6 TANGIBLE FIXED ASSETS**

Assets costing £5,000 or more are capitalised as tangible fixed assets and are carried at cost, net of depreciation and any provision for impairment.

Where tangible fixed assets have been acquired with the aid of specific grants, either from the government or from the private sector, they are included in the Balance Sheet at cost and depreciated over their expected useful economic life. Where there are specific conditions attached to the funding requiring the continued use of the asset, the related grants are credited to a restricted fixed asset fund in the Consolidated Statement of Financial Activities and carried forward in the Balance Sheet. Depreciation on the relevant assets is charged directly to the restricted fixed asset fund in the Consolidated Statement of Financial Activities. Where tangible fixed assets have been acquired with unrestricted funds, depreciation on such assets is charged to the unrestricted fund.

On conversion the School was granted a 125 year lease from the Local Authority for the land and buildings previously occupied by the local authority school. On conversion the long term leasehold property was recognised as a donation from the Local Authority and was valued using the depreciated replacement cost method.

Where the School has been granted use of the school buildings from the Salisbury Diocesan Board of Education under a Supplemental Agreement, the Academies Accounts Direction prescribes that where the School concludes it has control over access and works to the land and buildings they can be recognised as an asset.

The Supplemental Agreement includes the right for the Salisbury Diocesan Board of Education to give not less than 2 years written notice to the School and Secretary of State for Education to terminate the agreement. No such written notice has been received as at the date of the approval of these financial statements.

Depreciation is provided on all tangible fixed assets other than freehold land and assets under construction, at rates calculated to write off the cost of each asset on a straight-line basis over its expected useful life, as follows:

Depreciation is provided on the following bases:

Long Term Leasehold Land	- over the length of the 125 year lease
Long-term leasehold property	- 2% straight line
Building improvements	- 10% straight line
Plant and machinery	- 20% straight line
Fixtures and fittings	- 20% straight line

A review for impairment of a fixed asset is carried out if events or changes in circumstances indicate that the carrying value of any fixed asset may not be recoverable. Shortfalls between the carrying value of fixed assets and their recoverable amounts are recognised as impairments. Impairment losses are recognised in the Consolidated Statement of Financial Activities.

**1.7 DEBTORS**

Trade and other debtors with no stated interest rate and due within one year are recorded at the amount of the cash or other consideration expected to be received. Prepayments are valued at the amount paid.

**1. ACCOUNTING POLICIES (continued)**

**1.8 CASH AT BANK AND IN HAND**

Cash at bank and in hand includes cash and short-term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account and cash on deposit that has a notice period of less than 30 days.

**1.9 LIABILITIES**

Liabilities are recognised when there is an obligation at the Balance Sheet date as a result of a past event, it is probable that a transfer of economic benefit will be required in settlement, and the amount of the settlement can be estimated reliably. Liabilities are recognised at the amount that the Group anticipates it will pay to settle the debt or the amount it has received as advanced payments for the goods or services it must provide.

**1.10 FINANCIAL INSTRUMENTS**

The Group only holds basic financial instruments as defined in FRS 102. The financial assets and financial liabilities of the Group and their measurement bases are as follows:

*Financial assets* - trade and other debtors are basic financial instruments and are debt instruments measured at amortised cost as detailed in note 14. Prepayments are not financial instruments. Amounts due to the School's wholly owned subsidiary are held at face value less any impairment. Cash at bank is classified as a basic financial instrument and is measured at face value.

Cash at bank is classified as a basic financial instrument and is measured at face value.

*Financial liabilities* - trade creditors, accruals and other creditors are financial instruments, and are measured at amortised cost as detailed in notes 15 and 16. Taxation and social security are not included in the financial instruments disclosure definition. Deferred income is not deemed to be a financial liability, as the cash settlement has already taken place and there is an obligation to deliver services rather than cash or another financial instrument. Amounts due to the School's wholly owned subsidiary are held at face value less any impairment.

**1.11 OPERATING LEASES**

Rentals paid under operating leases are charged to the Consolidated Statement of Financial Activities on a straight line basis over the lease term.



**1. ACCOUNTING POLICIES (continued)**

**1.12 PENSIONS**

Retirement benefits to employees of the Group are provided by the Teachers' Pension Scheme ("TPS") and the Local Government Pension Scheme ("LGPS"). These are defined benefit schemes.

The TPS is an unfunded scheme and contributions are calculated so as to spread the cost of pensions over employees' working lives with the Group in such a way that the pension cost is a substantially level percentage of current and future pensionable payroll. The contributions are determined by the Government Actuary on the basis of quadrennial valuations using a prospective unit credit method. TPS is an unfunded multi-employer scheme with no underlying assets to assign between employers. Consequently, the TPS is treated as a defined contribution scheme for accounting purposes and the contributions recognised in the period to which they relate.

The LGPS is a funded multi-employer scheme and the assets are held separately from those of the Group in separate trustee administered funds. Pension scheme assets are measured at fair value and liabilities are measured on an actuarial basis using the projected unit credit method and discounted at a rate equivalent to the current rate of return on a high quality corporate bond of equivalent term and currency to the liabilities. The actuarial valuations are obtained at least triennially and are updated at each Balance Sheet date. The amounts charged to operating surplus are the current service costs and the costs of scheme introductions, benefit changes, settlements and curtailments. They are included as part of staff costs as incurred. Net interest on the net defined benefit liability/asset is also recognised in the Consolidated Statement of Financial Activities and comprises the interest cost on the defined benefit obligation and interest income on the scheme assets, calculated by multiplying the fair value of the scheme assets at the beginning of the period by the rate used to discount the benefit obligations. The difference between the interest income on the scheme assets and the actual return on the scheme assets is recognised in other recognised gains and losses.

Actuarial gains and losses are recognised immediately in other recognised gains and losses.

**1.13 AGENCY ARRANGEMENTS**

The School acts as an agent in distributing 16-19 bursary funds from ESFA. Payments received from ESFA and subsequent disbursements to students are excluded from the Statement of Financial Activities as the School does not have control over the charitable application of the funds. The School can use up to 5% of the allocation towards its own administration costs and this is recognised in the Statement of Financial Activities. The funds received, paid and any balances held at the period end are disclosed in note 27.

**1.14 FUND ACCOUNTING**

Unrestricted income funds represent those resources which may be used towards meeting any of the charitable objects of the Group at the discretion of the Trustees.

Restricted fixed asset funds are resources which are to be applied to specific capital purposes imposed by the funders where the asset acquired or created is held for a specific purpose.

Restricted general funds comprise all other restricted funds received with restrictions imposed by the funder/donor and include grants from the Department for Education Group.

Investment income, gains and losses are allocated to the appropriate fund.

**2. CRITICAL ACCOUNTING ESTIMATES AND AREAS OF JUDGMENT**

Estimates and judgments are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

Critical accounting estimates and assumptions:

The Board of Trustees trust makes estimates and assumptions concerning the future. The resulting accounting estimates and assumptions will, by definition, seldom equal the related actual results. The estimates and assumptions that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year are discussed below.

The present value of the Local Government Pension Scheme defined benefit liability depends on a number of factors that are determined on an actuarial basis using a variety of assumptions. The assumptions used in determining the net cost or income for pensions include the discount rate. Any changes in these assumptions, which are disclosed in note 23, will impact the carrying amount of the pension liability. Furthermore a roll forward approach which projects results from the latest full actuarial valuation performed at 31 March 2019 has been used by the actuary in valuing the pensions liability at 31 August 2020. Any differences between the figures derived from the roll forward approach and a full actuarial valuation would impact on the carrying amount of the pension liability.

Critical areas of judgment:

The School obtains use of fixed assets as a lessee. The classification of such leases as operating or finance lease requires the School to determine, based on an evaluation of the terms and conditions of the arrangements, whether it retains or acquires the significant risks and rewards of ownership of these assets and accordingly whether the lease requires an asset and liability to be recognised in the Balance Sheet.

Condition Improvement Fund (CIF) - Capital income from the ESFA to address condition need and expansion projects.

Named Pupil Allowance - Funding received to fund further support for pupils with additional needs.

Enhanced Learning Provision - Funding received to fund further support for pupils with a significant level of special educational need.

Alternative Provision - Funding received with the specific purpose of educating pupils who have been permanently excluded, or are at risk of permanent exclusion, and for work designed to prevent students from being permanently excluded.

Year 7 catch up - Additional funding from the ESFA paid like pupil premium to target those pupils in year 7

that had below target attainment at key stage 2 on leaving primary school.

Pupil Premium - Pupil Premium represents funding received from the ESFA for children that qualify for free school meals to enable the School to address the current underlying inequalities between those children and their wealthier peers.

Devolved Formula Capital - This represents funding received from the ESFA to cover the maintenance and purchase of the School's assets.

Educational visits contributions - Parental contributions to curriculum educational visits.

Other restricted donations - Donations received towards the Breathing Space and other specific projects.

Other restricted income - Donations received towards intervention and engagement funding.

Pension reserve - This represents the School's share of the assets and liabilities in the Local Government Pension Scheme. As with most pension schemes this is currently in deficit due to an excess of scheme liabilities over scheme assets which was inherited on conversion to an Academy. The School is following the recommendations of the actuary to reduce the deficit by making additional contributions over a number of years.

**RESTRICTED FIXED ASSET FUNDS**

Fixed assets on conversion represent the value of the building and other assets transferred to the new Academy Trust from the Local Authority.

Fixed assets purchased from GAG and restricted funds are assets purchased since conversion.

Section 106 Funding - Income from developers towards the costs of providing community and social infrastructure, the need for which has arisen as a result of a new development taking place.

**TRANSFERS BETWEEN FUNDS**

The transfer from GAG to the restricted fixed asset fund relates to fixed assets purchased.

**OTHER INFORMATION**

Under the funding agreement with the Secretary of State, the School was not subject to a limit on the amount of GAG it could carry forward at 31 August 2020.

## **23. PENSION COMMITMENTS**

The School's employees belong to two principal pension schemes: the Teachers' Pension Scheme England and Wales (TPS) for academic and related staff; and the Local Government Pension Scheme (LGPS) for non-teaching staff, which is managed by Wiltshire County Council. Both are multi-employer defined benefit schemes.

The latest actuarial valuation of the TPS related to the period ended 31 March 2016 and of the LGPS 31 March 2019.

There were no outstanding or prepaid contributions at either the beginning or the end of the financial year.

### **TEACHERS' PENSION SCHEME**

The Teachers' Pension Scheme (TPS) is a statutory, contributory, defined benefit scheme, governed by the Teachers' Pension Scheme Regulations 2014. Membership is automatic for full-time teachers in academies. All teachers have the option to opt-out of the TPS following enrolment.

The TPS is an unfunded scheme to which both the member and employer makes contributions, as a percentage of salary - these contributions are credited to the Exchequer. Retirement and other pension benefits are paid by public funds provided by Parliament.

### **VALUATION OF THE TEACHERS' PENSION SCHEME**

The Government Actuary, using normal actuarial principles, conducts a formal actuarial review of the TPS in accordance with the Public Service Pensions (Valuations and Employer Cost Cap) Directions 2014 published by HM Treasury every 4 years. The aim of the review is to specify the level of future contributions. Actuarial scheme valuations are dependent on assumptions about the value of future costs, design of benefits and many other factors. The latest actuarial valuation of the TPS was carried out as at 31 March 2016. The valuation report was published by the Department for Education on 5 March 2019. The key elements of the valuation and subsequent consultation are:

- employer contribution rates set at 23.68% of pensionable pay (including a 0.08% administration levy)
- total scheme liabilities (pensions currently in payment and the estimated cost of future benefits) for service to the effective date of £218,100 million and notional assets (estimated future contributions together with the notional investments held at the valuation date) of £196,100 million, giving a notional past service deficit of £22,000 million
- the SCAPE rate, set by HMT, is used to determine the notional investment return. The current SCAPE rate is 2.4% above the rate of CPI, assumed real rate of return is 2.4% in excess of prices and 2% in excess of earnings. The rate of real earnings growth is assumed to be 2.2%. The assumed nominal rate of return including earnings growth is 4.45%.

The next valuation result is due to be implemented from 1 April 2023.

The employer's pension costs paid to TPS in the year amounted to £1,013,982 (2019 - £698,838).

Under the definitions set out in FRS 102, the TPS is an unfunded multi-employer pension scheme. The Group has accounted for its contributions to the scheme as if it were a defined contribution scheme. The Group has set out above the information available on the scheme.

**23. PENSION COMMITMENTS (CONTINUED)**

**LOCAL GOVERNMENT PENSION SCHEME**

The LGPS is a funded defined benefit pension scheme, with the assets held in separate trustee-administered funds. The total contribution made for the year ended 31 August 2020 was £350,000 (2019 - £343,000), of which employer's contributions totalled £283,000 (2019 - £277,000) and employees' contributions totalled £ 67,000 (2019 - £66,000). The agreed contribution rates for future years are 24.8 per cent for employers and 5.5 - 12.5 per cent for employees.

The LGPS obligation relates to the employees of the School, who were the employees transferred as part of the conversion from the maintained school. The obligation in respect of employees who transferred on conversion represents their cumulative service at both the predecessor school and the School at the balance sheet date.

Parliament has agreed, at the request of the Secretary of State for Education, to a guarantee that, in the event of academy closure, outstanding Local Government Pension Scheme liabilities would be met by the Department for Education. The guarantee came into force on 18 July 2013.
